This left his knee swollen and he could not walk without assistance. His knee was X-rayed at Watford hospital and he was told to rest for a week.

4th October 2018 A glass cutter caught his knuckle and cut his finger while handing glass. The cut was plastered up. A review was made to check the operative was wearing the correct PPE as issued



by the company. The procedure was reviewed and all operatives were given refresher training in the handling of glass.
